Nothing herein shall affect the right to serve proceedings in any other manner permitted by law.</p> <p>(d) Other documents</p> <p>The Issuer has in the Agency Agreement and the Deed of Covenant submitted to the jurisdiction of the New York courts, waived any right it may have to claim sovereign or other immunity from jurisdiction or execution and appointed an agent for service of process in terms substantially similar to those set out above.”</p>
